
## Update Regarding Access to Court Case Information Through the Los Angeles Superior Court Justice Partner Portal (JPP)

Effective February 1, 2022, the [Los Angeles Superior Court Justice Partner Portal \(JPP\)](#) began providing access to the following court case information and minute orders: Juvenile Dependency, Criminal, Family Law, and Probate. Any DCFS staff member with access to JPP can now access these records, in addition to the Juvenile Dependency records that were previously available through JPP.

If a staff member needs to obtain access to JPP, they will need to complete the following steps:

1. Complete the: "Justice Partner Portal (JPP) Request Access Form" and obtain their manager's approval for access.
2. Submit an [IT Service Request](#) requesting JPP access with the completed/approved: "Justice Partner Portal (JPP) Request Access Form" attached.
