POLICY AND FYI RELEASE UPDATE - 2ND QUARTER 2024

This policy release update provides staff with a summary of new/revised guides and FYI's posted on LA Kids during the second quarter of 2024.

Policy Guides:

0070-548.20 Taking Children into Temporary Custody | Revision Date: 6/5/2024

This policy guide was updated to add modifications which reflect special procedures to follow when taking Indian children into temporary custody, and for the CSW to now report to court on the potential harms that may result from removing a child from their parent, guardian, or Indian custodian.

1200-500.30 - DCFS Countywide Drug and Alcohol Testing Program | Revision Date: 6/10/2024

This policy guide was updated to provide information regarding the use of the Testing Program, including additional information on use of temporary identification (ID), updates on enrolling youth (minors) in testing, as well as updates to specialized schedule testing.

0080-507.22 Family Finding and Engagement Program (FFEP) | Revision Date: 6/13/2024

This policy guide was updated to provide information on establishment of the Family Finding and Engagement Program, which combines the Upfront Family Finding (UFF) Program and Permanency Partners Program (P3). The name of this procedural guide was also changed from Permanency Partners Program (P3) to Family Finding and Engagement Program (FFEP).

FYI 24-06 SHORT-TERM RESIDENTIAL THERAPEUTIC PROGRAM (STRTP) CENTRALIZATION
