Transition to Microsoft Teams for all Dependency Court Virtual Hearings

The Los Angeles Dependency Court is transitioning from WebEx to Microsoft Teams for all virtual court hearings in Monterey Park, Pomona (POM), Compton (COM), and Antelope Valley (AMJ). This change affects all DCFS notices on SNAP 2.0 for court hearings.

Effective Dates:

Courtroom(s)	SNAP 2.0 Update Applied	“Go live”/ Teams Implementation Date
Dept. 416 (pilot)	May 5, 2025	June 16, 2025
All other Departments	April 21, 2025	July 14, 2025

Required Action:

If a hearing is scheduled on or after the “go live” date (see table above), and the notice included outdated WebEx information (i.e., generated prior to the applicable SNAP update), the following steps must be taken:

1. **Send an Updated Appearance Sheet to all parties:** Send to parents/guardians, children/nonminor dependents, relatives, siblings, de facto parents, caregivers, Court Appointed Special Advocate (CASA). Delivery methods: text (verify number and delivery), mail, in-person, or phone.
2. **Confirm Understanding:** Explain that the updated Teams link is specific to their upcoming hearing date. Confirmation of receipt is strongly encouraged.
3. **Document in LMI:** Submit a Last Minute Information (LMI) stating how the updated information was delivered, the party’s response, and how receipt was confirmed (if applicable).
4. **Special Instructions for 366.26 Hearings:** If notices for a WIC 366.26 hearing were already sent using WebEx, contact your outstation or trial court County Counsel for guidance.
