ENGAGEMENT WITH INCARCERATED PARENTS

On July 23, 2024, the Board of Supervisors approved a revised motion regarding Removal of Barriers to Family Reunification, directing Department of Children and Family Services (DCFS), in collaboration with LA County Sherriff's Department, to report back on:

- Data regarding incarcerated parents involved in both systems
- Available services and gaps in services for incarcerated parents
- Exploration & collaboration with community-based organizations to provide services, programs and resources for shared parents.

As a result to the motion, DCFS and LASD formed a collaborative workgroup to improve (or align) services to parents involved in both systems. The purpose of this FYI is to inform staff on the availability of resources and services available to incarcerated parents. The information in this FYI is organized under the following categories:

Selecting and/or Arranging for Appropriate Services for Incarcerated, Institutionalized, Detained or Deported Parents - 0080-506.16		This policy guide specifies the requirements and procedures for family reunification services for parents who are incarcerated, institutionalized, detained, or deported.
Family Time - 0400-504.00		This policy, previously known as Family Visitation, addresses family time between children, parents, siblings, and other significant relatives and individuals. It ensures all family time tools protocols, and strategies are easily accessible when planning meaningful family time. Family time is currently still referred to as visitation in the statutes, case law, and court orders.

An incarcerated parent has a right to participate in the case plan and complete services, unless deemed otherwise by Dependency Court. The facilities may offer various services for the incarcerated parent. The list of resources and contact information are being provided to assist staff in meeting court orders to determine what services are available in a parent's place of incarceration as available programming varies.

Parents in Partnership (PIP)	DCFS PIPs have successfully navigated DCFS and now work to support, provide information, and mentorship to parents who have temporarily or permanently lost custody of their children. PIPs also provide parent advocacy services such as lobby outreach, parent orientations, parent support groups, and Child and Family Team support. PIPs work in collaboration with LASD to provide support inside the jail facilities. PIPs conduct a DCFS Orientation twice a month at CRDF.
