Adobe e-Sign for Court Report

This FYI is to inform staff that effective **February 23, 2021**, the Department is implementing Adobe e-Sign to allow for the electronically signing of Court Reports.

BACKGROUND:

The new electronic filing system at the Dependency Court has made it necessary for the Department to implement a process that digitally captures signatures on Court Reports. The Business Information Systems Division has partnered with Adobe to create a method to facilitate this process. The Adobe e-Sign software enables Court Reports to be signed and submitted electronically via a workflow process.

HOW IT WORKS:

The primary function of Adobe e-Sign is to capture digital signatures. This digital signature process is in compliance with all County rules and regulations and acceptable by LA Superior Court. The Adobe software does not allow for changes to any document once the signature process has begun. Therefore, CSWs and SCSWs must ensure that the grammar and content of the Court Report is final **(e.g., spellcheck, formatting, acronym usage)** before initiating the e-signature process in Adobe.
